Parent Consent Form for taking photographs and recording film images of children and young people.

English Martyrs Catholic Primary School has a responsibility to ensure the welfare and safety of children and young people. Within school photographs and videos are taken of the children at our school. The main purpose of taking photographs and video /film is to celebrate the success of pupils and to record learning and achievements. We use these images as part of our school displays, in pupil/curriculum books, a record of school trips and events and sometimes in other printed publications. We will also use them on our school website, newsletters, emails, You tube and Twitter account.

Additionally your child's image may be used outside of the school setting. Common instances may involve promotion of the school to the local community and parish or in competitions, images may appear in publications or channels used by the local authority or the media eg print or on the internet.

If permission is not given in advance then a child will be removed from a photograph before the photograph is taken. Please note, unless explicit permission is given by the school, parents/visitors must never take photographs or film of children in any school related activities. No parent/visitor should put pictures of children that are not their own on any social media network or distribute them to others.

In order to comply with the Data Protection Act 1998 and the new GDPR regulations in May 2018 a lawful basis is required before capturing images of a child. Your child's identify will not be disclosed without your consent and only if the photograph is used to celebrate individual success. Therefore we need your permission before we can photograph or make any recordings of your child. Please answer the questions below, then sign and date the form where shown and return the completed form to the school.

I give permission for my child's image to be used on local authority social media sites eg Twitter, Facebook and You Tube. These sites are accessible to the general public.		
I give permission for my child to be filmed and put on the school website via You Tube. NB these sites are accessible to the general public however the school You Tube is a private account and can not be searched for or accessed through You Tube but only seen on the school website.		
I give permission for my child 's image or film in authorised school events such as school productions, sports day both by the school and other parents/visitors, with the explicit understanding that parents/visitors are not permitted to put or distribute images or film on social media sites or via other medias which have images of other children.		
I give permission for my child to have a school photograph taken by a professional photographer. I understand that this printed/digital photograph can be purchased by parents.
